The Night Dispatcher position will be placed on the 2025 Spring Run-Off election ballot.

NOTIFICATION OF SPECIAL ELECTION **BUDGET/DUES INCREASE**

A motion was passed and carried on January 9, 2025, Stop Work Meeting, to accept the Amended Budget Proposal approved by the Executive Board on December 12, 2024. The Proposed Budget increases dues from \$219.75 to \$254.98. An increase of \$35.23. This dues increase is a result of increased costs to our per capita and pro rata charges by the Coast and International as well as increased administrative costs to keep our Local running.

ELIGIBILITY TO RUN FOR OFFICE

In accordance with Constitution and By-Laws, Article IV, Nomination of Officers, Section 1, Sub-Section (f) and Article XI, Dues Fines and Assessments, Section 1, Sub-Section (b). For a member to be considered in good standing, they shall have their dues, fines, and assessments paid in full every month for twelve consecutive months, prior to picking up a nomination form. No nomination form shall be issued to a member if this criteria has not been met.
